PBH's Board of Directors developed a Strategic Plan to guide the organization's direction over the next three to five years. This effort was funded by a HRMC Community Grant through Amarillo Area Foundation. We partnered with Heal the City Free Clinic who referred 32 Women to our mammogram program in 2024. We received the NAACP Amarillo Branch Community Service Award. We started two new initiatives: Its Not Too Early Campaign, which educates young women on the importance of breast health and encourages them to schedule their first mammogram at 40(funded, in part, by the Harrington Cancer and Health Foundation) and Improving Senior Mamography Rates in Partnership with the Area Agency on Aging, which educates senior women about screening guidelines and encourages them to continue getting mammograms(funded, in part, by the Mary E Bivins Foundation).

Transcending Limits and Positively Pink Cancer screening initiatives have enabled Panhandle Breast Health to hold 36 events and interact with more than 400 people in eight counties, directly paid for 39 procedures and partnered with The Ryan Palmer Foundation and Haven Health Clinics to fund screenings for those that don't qualify for other programs, screenings and services.
